

## 2<sup>nd</sup> Transnational Project Meeting

### SELCERT: Skills Development and Certification for Trainers of Synchronous Electronic Learning

The 2nd Transnational Meeting of the project SELCERT: Skills Development and Certification for Trainers of Synchronous Electronic Learning, coordinated by EURO-IDEA and hosted by ASNOR, took place in Bari, Italy on the 4th and 5th of April 2023. The meeting was hybrid since M.M.C, CCC, FU, ASNOR, and EURO-IDEA participated physically whereas DIMITRA, and OMEGATECH connected through Zoom. During these two days of meeting, all participating partners contributed to the smooth execution of the meeting.

The first day of the meeting started with a welcoming note from the project's coordinator, EURO-IDEA, and then a discussion around the interim report and indicators was held. Also, the partners brought to attention some clarifications regarding the dissemination of the project. Additionally, FU, as the leading organisation of Quality Assurance, presented its approach to quality assurance by demonstrating the tools, the qualitative and quantitative indicators, the evaluation reports, etc. Just before the end of the first day's meeting, MMC presented the focus group reports that were followed by the introduction of the Qualification Framework. The last activity of the first meeting was the partners' workshop to validate the qualification framework which was split into two days and indicated the beginning of the second day's meeting.

During the second day of the meeting, the partners discussed and agreed on the learning outcomes of the qualification framework and called for the completion of PR1: Qualification Framework for the Trainers of Synchronous Electronic Learning. In addition, CCC presented PR2: Certification Schemes For Curricula and Training Materials and Certification Scheme for the Certification of Persons [the SEL trainer]. The partners listed some essential criteria for the recruitment of assessors and specified some indicators regarding the two certification schemes. Also, PR3: ISO Certificated Curriculum for Trainers of Synchronous Electronic Learning and PR4: Materials and Digital Methodological Tools (on a platform) for Synchronous e-Learning for the SEL trainers were discussed, and responsibilities and tasks were allocated to partners.

Overall, the 2nd Transnational Meeting was very productive and beneficial for everyone who participated. It was a great pleasure for the partners to meet again and share fruitful ideas for the project's progression. These two successful days ended with the confirmation of the 3rd TPM in Nicosia, Cyprus on 18-19 September 2023.
